## Framework Facilities & Equipment Rental Policy and Conditions

### **Rental Agreement**

Lessor and Lessee agree that this Agreement shall apply to rental of stage facilities and or equipment by Lessee from Lessor occurring on or after the date of this Agreement even though the specific Property, duration of rental and/or the price for the rental may vary. The parties acknowledge and agree that the terms and conditions of the Agreement shall continue to apply to all future rental transactions between them, without necessity of either party executing a new Agreement.

The lessee, whose company or name and authorized signature appears on this Agreement, hereby rents from Framework Studio LLC (Framework) the equipment, stage facilities, grip truck and or services described, and acknowledges receipt of said equipment in working order. A certificate of insurance must be received prior to the date of rental (see insurance requirements).

#### **Rental Periods**

Minimum studio rental period is 3 hours for an hourly rental. A half day rental is any rental that is between 3 and 5 hours, and a full day rental is up to 10 hours. Minimum equipment rental is one full day. Late fees may apply if returned late or used beyond specified time and dates. All equipment must be operated by qualified technicians. Framework requires authorized (by Framework) persons to operate some stage equipment.

#### **Overtime**

Any time beyond the reserved rental period on an hourly, half day or full day rental, will be billed at the standard hourly rate of \$100/hour.

### **Payment Terms**

Payment terms are NET 30 days, except for out-of-state lessees and first time customers who may be asked for payment up front and before scheduled services. A late fee of 5% per month will be applied after 30 days.

### Liability

Lessee hereby agrees to indemnify and hold harmless Framework, its owners, officers and employees from all claims, suits, damages, losses and liabilities (including Worker's Compensation for lessee's employees, agents and contractors either full-time or day-hired), including attorney fees for loss of life or injury to any person, damage to the facility or equipment or other damages or losses whatsoever, resulting directly or indirectly from a cause or occurrence in, upon, at or from the use of rented stage facilities and or property, including

but not limited to such damage or injury which may be caused by the negligence of Framework, its agents, officers or employees. Framework is not responsible for lessee equipment, props or other items personal or rented that does not belong to Framework and is stored or left on or at a Framework's facility at any time.

\* If you have not provided us with Insurance please refer to the Insurance Requirements section and submit your certificate to us before entry.

## **Damaged Stage Facilities and/or Equipment**

Our stage facilities and equipment rentals are offered for inspection and testing at the time of rental. All facilities and equipment are rented in good condition and are to be returned in the same condition. Any repair work necessary shall be paid by lessee. If equipment or parts of facility is damaged beyond repair lessee shall pay full replacement price. Lessee is responsible to reimburse Framework for loss of rentals/income during repair session or replacement process. Lessee is responsible to leave the stage facilities in the rental condition found upon entry to avoid a cleaning fee. All stage rentals are subject to a cleaning/re-painting fee.

### **Legal Action**

Any dispute under or pursuant to this Agreement shall be controlled by Oregon Law. Should lessee default, or fail to perform under any provisions herein, lessee agrees to pay reasonable attorney's fees and other costs actually incurred by Framework in enforcing such provisions. This agreement involving equipment, facilities, and services shall not be amended or modified except by mutual agreement, in writing, signed by both parties.

Automobile Liability Insurance in an amount not less than \$1,000,000.00 Combined Single Limit (for rented autos).

Physical Damage Endorsement (Comprehensive and Collision for Non-owned and hired vehicle) on a blanket basis to any vehicle that Framework may provide to the lessee.

## Equipment Rental:

All Risks Insurance on all equipment rented from Framework in the amount of \$100,000.00 for the contents of the grip truck or other amount specified for "equipment only" rentals. Certificate of Insurance (Certificate Holder, Loss Payee and Additional Insured must read Framework Studio LLC and include our address)

Insurance must be verified by providing Framework a certificate of insurance containing the following:

- 1. List Framework as Loss Payee as respects misc., equipment, physical damage to autos, and comprehensive and collision.
- 2. List Framework as Additionally Insured as respects to: third party property damage, comprehensive general & auto liability.
- 3. Provide for a 10 day written notice of cancellation or reduction in coverage.

<sup>\*</sup> All certificates should cover the time of rental starting with the pick up date and ending with the return date. One year certificates are recommended.
